

CSA T20 CHALLENGE 'Snatch the Stash'

TERMS AND CONDITIONS

1 DEFINITIONS

These Terms and Conditions ("T&C's") relate to the "Snatch the Stash – 2019 CSA T20 CHALLENGE" Competition.

Clause headings are inserted for convenience only and shall not be used in its interpretation. The following expressions shall bear the following meanings and related expressions bear corresponding meanings –

"Competition" – shall mean the "Snatch the Stash COMPETITION – 2019 CSA T20 CHALLENGE";

"Participant" – means any South African citizen who enters to win this Competition;

"Promoter" – means **TITANS CRICKET (PTY) LTD** (registration number 1991/115800/07), company duly registered and incorporated in terms of the company laws of the Republic of South Africa with its head office situated at SuperSport Park, Centurion;

"Competition dates" – means 26 April 2019 and 28 April 2019;

"Prizes" – means R100 000.00 (One Hundred Thousand Rand) for the first winning catch as described in paragraph 3 & 4 below and R50 000.00 (Fifty Thousand Rand) for the second winning catch as described in paragraph 3 & 4 below;

"Winning Catch" – means a catch which qualifies to win the Competition as described in paragraph 4 below.

2 HOW TO ENTER

Catch a six with one hand at the **2019 CSA T20 CHALLENGE** matches played at SuperSport Park, Centurion (Titans versus Knights) on 26 April 2019 and at SuperSport Park, Centurion (Titans versus Lions) on 28 April 2019.

3 PRIZES

The prize money in total is valued at R150 000 and will be allocated as per the following scenarios:

- 3.1 R100 000.00 (One Hundred Thousand Rand) for the **first person** who catches a six with one hand at SuperSport Park on 26 April 2019 during the match Titans versus Knights in accordance with these T&C's.
- 3.2 R50 000.00 (Fifty Thousand Rand) for the **second person** who catches a six with one hand at SuperSport Park on 26 April 2019 during the match Titans versus Knights in accordance with these T&C's.
- 3.3 Should **no catches** be taken at SuperSport Park on 26 April 2019 during the match Titans versus Knights:

(3.3.1) R100 000.00 (One Hundred Thousand Rand) for the **first person** who catches a six with one hand at SuperSport Park on 28 April 2019 during the match Titans versus Lions in accordance with these T&C's.

(3.3.2) R50 000.00 (Fifty Thousand Rand) for the **second person** who catches a six with one hand at SuperSport Park on 28 April 2019 during the match Titans versus Lions in accordance with these T&C's.

3.4 Should **only one catch** be taken at SuperSport Park on 26 April 2019 during the match Titans versus the Knights:

(3.4.1) R50 000.00 (Fifty Thousand Rand) for the **first person** who catches a six with one hand at SuperSport Park on 28 April 2019 during the match Titans versus Lions in accordance with these T&C's.

4 THE WINNING CATCH

To qualify for the Prizes, the following criteria will apply to a Winning Catch –

- 4.1 The catch must be a clean (juggling the ball between hands will not be accepted as a clean catch), one-handed catch off a 'six' hit during the **2019 CSA T20 CHALLENGE** matches played at SuperSport Park, Centurion (Titans versus Knights) on 26 April 2019 and at SuperSport Park, Centurion (Titans versus Lions) on 28 April 2019.
- 4.2 The catch must be captured and clearly visible on stadium video as it will be audited.
- 4.3 For the avoidance of doubt, a clean catch is a one handed catch where the ball does not make contact with anything or anyone, i.e. it cannot bounce off any other person or object after leaving the bat until caught one-handed by the Participant after being struck out of the field of play.
- 4.4 Either hand can be used to make a clean catch.
- 4.5 No gloves, whether sporting gloves (e.g. cricket wicket keeping gloves, baseball mitts, hockey gloves, etc.) or any other form of glove; or any other form of artificial assistance may be used to catch the ball with.
- 4.6 The ball may only be caught with a "clean" hand.
- 4.7 No Prize will be awarded unless or until verification of the Winning Catch is made by the Promoter and the Promoter is satisfied, in its absolute discretion, that the criteria for a Winning Catch and the Competition's T&C's have been met.
- 4.8 The catch will be adjudicated by an Independent Adjudicator appointed by the Promoter.

- 4.9 In verifying the Winning Catch, the Adjudicator may require statements from spectators who witnessed the Winning Catch.
- 4.10 The Adjudicator will confirm or deny the catch.
- 4.11 The Promoter's decision is final.
- 4.12 Any alleged Winning Catch not captured on a camera and therefore not able to be reviewed by the Promoter will be deemed a non-eligible catch.

5 MATCHES

- 5.1 The Competition is for the **2019 CSA T20 CHALLENGE** matches played at SuperSport Park, Centurion (Titans versus Knights) on 26 April 2019 and at SuperSport Park, Centurion (Titans versus Lions) on 28 April 2019.
- 5.2 Any changes made to the scheduled dates are outside of the Promoter's control.
- 5.3 Participants will be solely responsible for ensuring that they keep up to date of all such changes.
- 5.4 The Promoter will not be liable to any person as a result of any such changes.

6 PROMOTIONAL PRIZES

The award of the Prizes is subject to the following terms and conditions:

- 6.1 A Participant who successfully completes a Winning Catch in accordance with the Competition's T&C's will be entitled to receive the Prize;
- 6.2 The Prize will be a maximum of R100 000.00 (One Hundred Thousand Rand) for the first winning catch as described in paragraph 3 & 4 above and R50 000.00 (Fifty Thousand Rand) for the second winning catch as described in paragraph 3 & 4 above for the Participant successfully completing a Winning Catch in accordance with these T&C's;
- 6.3 The Prize will be paid by means of electronic funds transfer into the winner's nominated South African bank account on a date to be advised by the Promoter.
- 6.4 If the winner is under the age of 18, the Prize shall be paid into a Trust Account administered by Titans Cricket. It will be held in trust until such time as the Participant turns 18 after which it would be paid over to the Participant. Titans Cricket will enter into a separate agreement with the participant with regards to the management of the Trust Account.
- 6.5 The Prize will be paid to the winner/s at the end of the **2019 CSA T20 CHALLENGE** and no later than 31 May 2019;
- 6.6 Any South African citizen is eligible to enter the Competition or receive the Prize;

- 6.7 It is the Prize winner's responsibility to ensure that the correct name, address and bank account details are provided to the Promoter;
- 6.8 The Promoter accepts no responsibility for any prize/s deposited into the wrong or incorrect bank account;
- 6.9 The Promoter reserves the right to conduct a security verification check at its absolute discretion;
- 6.10 A Prize winner may be required to sign a declaration confirming his or her eligibility to accept the Prize; and
- 6.11 The Promoter reserves the right to request proof of identity and proof of residency from any Prize winner.
- 6.12 Proof of identity includes, but is not limited to, a valid driver's licence, identity document, passport and/or bank account details.

7 GENERAL TERMS AND CONDITIONS OF ENTRY

- 7.1 To participate in and/or claim a Prize in the Competition, Participants must be South African Citizens.
- 7.2 Participation in the Competition is deemed to be acceptance of these T&C's by the Participant or, in the case of a Participant under the age of 18, his or her legal guardian.
- 7.3 Should there be a dispute, a Participant is entitled to make representations in writing to the Promoter during the Competition Period. The Promoter shall consider such representations and notify the Participant in writing as to the decision taken in respect of the dispute. The Promoter's decision in this regard shall be final and binding. No reasons shall be required in respect of such decision and no further correspondence will be entered into.
- 7.4 The Promoter reserves the right, in its absolute discretion, to change the T&C's without prior notice and at its discretion or extend, postpone or discontinue the Competition at any time.
- 7.5 The Promoter reserves the right to withdraw this Competition without notice in the event of force majeure.
- 7.6 For the purposes of these T&C's an event of force majeure shall include but not be limited to any event beyond the reasonable control of a party, such as war, earthquakes, disasters, calamities, strikes or similar circumstances (including the threat thereof).
- 7.7 The Promoter may refuse to award a prize to any Participant if, in the Promoter's sole opinion, that Participant has violated the T&C's or has gained an unfair advantage in participating in the Competition.
- 7.8 The Prize is non-transferable.

- 7.9 All Participants enter and participate in this Competition at their own risk. The Promoter will not be liable for any damage or injury whatsoever incurred by any Participant when participating in the Competition (including but not limited to any indirect or consequential loss).
- 7.10 All Prizes are received entirely at the Prize winner's own risk.
- 7.11 Prize winners indemnify the Promoter against any liability for accident or loss of life, personal injury, property damage or other loss, cost or expense arising from any claim by any third party in connection with their participation in the Competition.
- 7.12 Prize winners are advised that tax implications may arise from the Prize winnings and the liability for such tax as well as any independent tax and financial advice that a winning Participant may seek shall be at his/her cost and account.
- 7.13 The Promotion commences at 18h00 on 26 April 2019.
- 7.14 The Promotion closes at midnight on 28 April 2019. No entries will be accepted outside of these dates.
- 7.15 These T&C's are subject to all applicable venue and licensing laws and regulations.
- 7.16 These T&C's will be made available on the Promoter's website at <http://www.titans.co.za> and during the **2019 CSA T20 CHALLENGE** matches played at SuperSport Park, Centurion (Titans versus Knights) on 26 April 2019 and at SuperSport Park, Centurion (Titans versus Lions) on 28 April 2019.
- 7.17 By reading and accepting these terms and conditions, the Participant gives consent to these risks and hereby indemnifies and holds harmless the Promoter; their directors, employees and agents of any and all liability pertaining to any damage, cost, injuries and losses of whatever nature sustained as a result of their participation in the Competition and related events and activities, save where such damage, cost, injuries and losses are sustained as a result of the gross negligence or wilful misconduct of any indemnified party.
- 7.18 The Promoter; Cricket South Africa, South African Cricket Unions/Franchises; their directors, members, partners, employees, agents or consultants, the suppliers of goods or services in connection with this Competition, or any other person who directly or indirectly controls or is controlled by the above named parties and their respective spouses, life partners, business partners or immediate family members are not permitted to participate in this Competition.

8 PROMOTIONS AND USE OF INFORMATION

By participating in the Competition, Participants consent to:

- 8.1 The use of their name, photograph and video footage for any promotional purposes carried out by the Promoter;
- 8.2 Attending prize-giving and other promotions in the Promoters Brand / Clothing;

- 8.3 Participants in the Competition agree that the Promoter may retain the Participant/s personal information in order to conduct and administer the Promotions and for future promotions carried out by the Promoter;
- 8.4 A request to access, update or to remove any information should be directed to the Promoter at the address set out above.
